Warranties Explanatory Notes

- Heirloom reserves the right, to alter design, materials, and specifications without prior notice as part of our ongoing commitment to product improvement.
- All dimensions are subject to manufacturing tolerances and should be checked before installation.
- Product quality and condition must be checked prior to installation.
- Warranties unless otherwise stated are for all products installed in domestic residential
 situations and/or light commercial situations such as kitchens, bathrooms and laundries in
 motels, hotels and retirement villages, but are subject to correct installation, use and care.
 Commercial situations such as public washrooms and or kitchens and laundries in public
 buildings, sports facilities, gymnasiums and hospitals are not included in this warranty.
 Note: soft close seat action is not warranted in commercial situations
- Heirloom Warranties commence from date of purchase and must be supported by proof of purchase. They do not start at the date of installation.
- Products must have always been maintained in good order and if necessary serviced in accordance with Heirloom's maintenance instructions.
- Warranties cover defective materials and workmanship. Warranties do not cover claims
 caused or contributed to by, incorrect installation, operation, misuse, damage accident
 or product neglect, environmental excessive water pressure conditions, water pressure or
 temperature, or do they cover consequential loss.
- This warranty does not cover normal wear and tear.
- Products must have been cleaned following the manufacturers guide. The use of incorrect cleaning products (particularly ammoniated or abrasive) will void the warranty. Refer to our Care and Maintenance instructions which form part of this warranty document, or visit Heirloom's website www.heirloom.co.nz to download a Guide.
- A product affected by accepted warranty claims will be repaired or replaced at Heirloom's option.
- This warranty is for the original or first end-user and is not transferable, unless expressly agreed to in writing by Heirloom for a specific situation.
- Any warranty claim must be applied for online, where possible, using Heirloom's Service Request form and accompanied by any photo or video which clearly shows the damage or defect that the claim is being made for.
- Products must have been installed in accordance with the instructions enclosed with the product and also comply with the local City or Council Standards or regulations.
- Towel warmers must be installed by a registered electrician. Toilets and basins must be installed by a registered plumber.
- Heirloom reserves the right to determine any issue or uncertainty in connection with the warranty.
- All warranty-covered repair work must be carried out by an Heirloom representative or authorised service agent, electrician or plumber who has received a job or order number. Product testing, alterations or repair other than by a pre-approved Heirloom service agent are not covered.





Warranties Explanatory Notes (continued)

- Heirloom's responsibilities and obligations are for the repair or replacement of the product using their own appointed of service agent. Heirloom will not accept any costs for work done by any unauthorised service agent, plumber or electrician to determine the fault of the product.
- Heirloom International Limited is not responsible for labour or installation charges removal of existing product or any other expenses associated with a defective product. Heirloom's sole responsibility is replacement or repair of a defective product per this warranty coverage.
- Callouts will only be compensated by Heirloom, if they are accompanied by an appropriate Heirloom Authorisation or Job number.
- This warranty does not try to circumvent your rights under the Consumer Guarrantees Act. If your goods have been aquired by "trade" however, you agree that the Consumer Guarrantees Act does not apply.
- When Heirloom exchanges/replaces a product under warranty, the original warranty period remains as per the original product.

Warranty does not include

- Improper or unsuitable use.
- Incorrect installation ie. not in accordance with the installation instructions provided.
- Installation or part installation by the purchaser or any person other than a Licenced Plumber or Electrician (Towel Warmers).
- Normal wear and tear, misuse accident or neglect.
- Inadequate or total lack of maintenance.
- Chemical, electrochemical, or electrical influences
- Harsh detergents or abrasive cleaners used on finishes.

Exclusions

To the fullest extent by law, Heirloom excludes all liability for damage or injury to any person damage to any property, and any indirect consequential or other loss or damage.





Additional Information, Toilet Installation

Heirloom toilets

THE USE OF 80mm UPVC WASTE PIPE IS NOT RECOMMENDED

- For proper product performance it is our recommendation that when installing plumbing systems for the removal of waste from the toilet and/or waste trap bend, the installing plumber must use all means required under the AS/NZ3500 standards (where applicable). This is to ensure that both the toilet and Plumbing system can adequately function without risk of leaks, blockages or sufficient fall. It is recommended to use one set of standards when installing our products to ensure the product functions in accordance with the standards used and good plumbing practice.
- Heirloom recommends the use of 100mm uPVC waste pipework where possible to reduce the risk of blockages, and/or the risk of localised back-pressure when flushing the toilet. For example an 80mm waste pipe may cause back-pressure when flushing.
- Our toilet pans should be installed with 100mm uPVC certified waste pipework.

THE USE OF OFFSET PAN CONNECTORS

• The use of any offset pan connector on "S" toilet pan installations is not an acceptable solution to achieve a set out, as these connectors will compromise the waste discharge and can void the product warranty.

SEALANTS

• Please be aware that the use of a silicone sealant in the installation of any of our toilet suites, apart from sealing the pan to the floor or in the case of a wall-hung pan to the wall, may void the warranty of your toilet suite.
